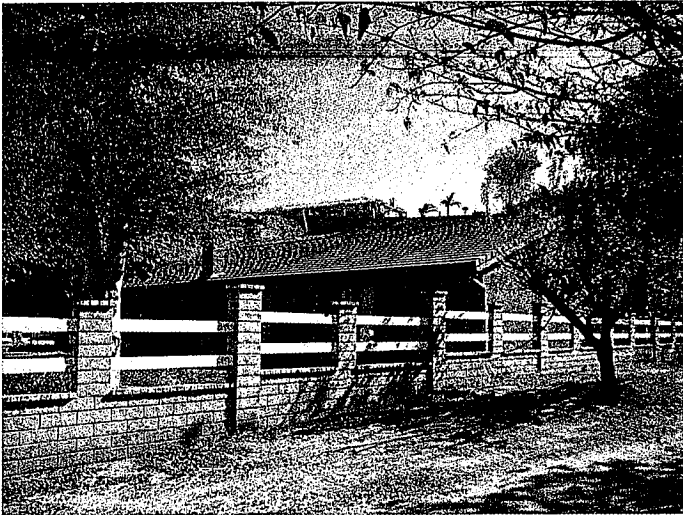

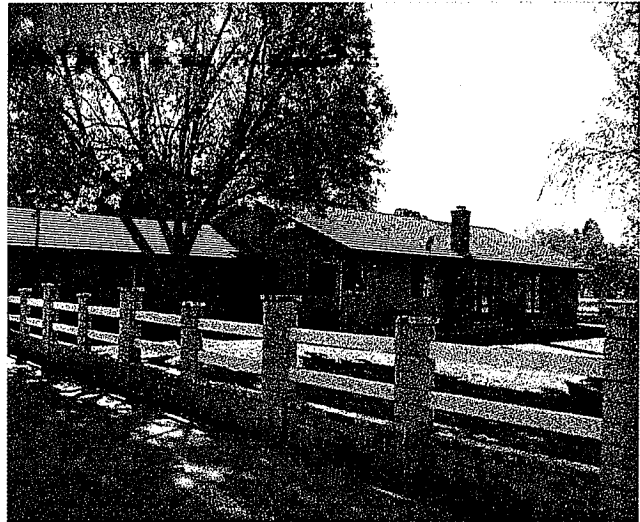

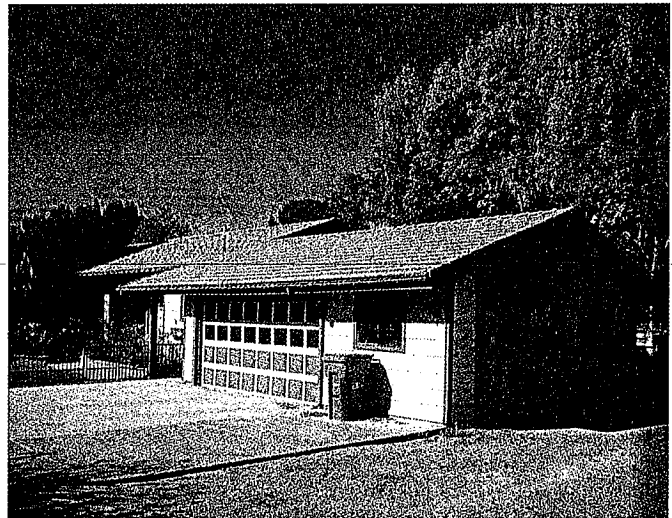
NORTH WEST SIDE OF HOUSE (REAR)
