The Special Needs Registry (SNR) helps Santa Clarita Sheriff's Deputies recognize and respond to local people with special needs. Residents are invited to use the SNR to proactively provide information about a loved one with special needs of any age who may require special assistance in an emergency or other encounter with deputies.

HOW THE REGISTRY WORKS

The information you provide in the SNR can save precious time in an emergency and help deputies do their job.

The SNR provides deputies with:

- ★ A photograph and description of the person with special needs.
- ★ Contact information for caregivers and doctors.
- ★ Medical, safety and behavioral concerns.
- ★ Accommodations for interacting and communicating with the person.
- ★ Information needed to find a missing person or identify someone who is found.
