FINAL BUDGET ADJUSTMENTS

The following are charges approved by the City Council to the proposed 1989-90 Annual Budget:

- 1. Revenue Increases Adjust estimate of Property Tax Revenue by 2% increase, \$60,000.
- 2. Administrative Services Increase City Manager's Office Printing account by \$800 for printing 5.000 copies of Library information brochure. Reduce the Contingency Reserve account by \$187,200 for budget amendment adjustments. Increase the City Manager's Office budget by \$25,000 for the Neighborhood Grants Program. Increase the City Manager's budget by \$25,000 for contribution to the Historical Society.
- 3. <u>Public Works</u> Increase Public Works Administration Contractual Services by \$25,000 for a water services study. Increase Public Works Administration, Salary and Fringe Benefits accounts by \$25,000 for a full-time Emergency Preparedness Coordinator.
- 4. Public Safety Increase Police Services Community Relations/Contractual Services account by \$84,000 for an additional S.A.N.E. program deputy to conduct programs in private schools. Increase Police Services, General Law Enforcement by \$7,400 for City's inclusion in the California I.D. program.
- 5. Parks and Recreation Increase the Parks Maintenance Part-time Employees account by \$15,000 and the Special Supplies account by \$10,000 for the Youth Summer Tree Planting/Replacement Program. Increase the Parks Maintenance Equipment account and reduce the Street Median Improvement Capital Project account by \$1,000 for the purchase of a paint sprayer for use by the Pride Week Committee.
- 6. <u>Capital Projects</u> Include in the fiscal year 1990-91 the development of bike trails on Soledad (\$500,000) and Bouquet Canyon (\$400,000). Include Calgrove straightening/widening in the 1990-91 fiscal year capital budget (\$10 million).
- 7. Community Development Increase the Economic Development Program Salary and Fringe Benefits account by \$30,000 for an Assistant Planner position previously budgeted but overlooked in the budget preparation.


