PROPOSED SUBSTANTIAL AMENDMENT

The City of Santa Clarita (City) proposes to make the following amendments to its 2018-2019 Annual Action Plan (AAP):

- Use \$105,782 in savings from the 2017-2018 program year for the Canyon Country Inclusion Playground project described in the 2018-2019 AAP.

BACKGROUND

After the close of the 2017-2018 program year, the City identified \$105,782 which was allocated in the 2017-2018 AAP, but not spent (see attachment A for specific areas of savings). In the 2018-2019 Annual Action Plan, the City funded the Canyon Country Inclusion Playground project with \$581,970 in 2018-2019 Entitlement funds. The City proposes to add the \$105,782 in savings from the 2017-2018 program year to the 2018-2019 AAP for the Canyon Country Inclusion Playground project. This amendment will increase the total funding for the Canyon Country Inclusion Playground project to \$687,752.

PUBLIC PARTICIPATION

In accordance with the City's CDBG Citizen Participation Plan, the public was notified that the above proposed amendments are available for review and comment through the following methods:
