BOUQUET CANYON ROAD BRIDGE OVER BOUQUET CREEK



Project Location: Bouquet Canyon Road at Bouquet Creek.

Description: This effort will provide for the design and rehabilitation of the 2-lane bridge over Bouquet Creek. Improvements will include widening of the shoulders and upgrades to bridge railing.

Justification: The existing bridge at this location should be widened to accommodate the addition of shoulders along this bridge and to bring it up to current standards. Addressing this issue now is vital as development in nearby areas will impact this portion of the roadway. The 1999 Bridge Inspection Reports identify necessary repairs to this bridge and the City has been granted authorization to proceed with design.


Project Location: I-5 and Magic Mountain Interchange


Project Location: Bouquet Canyon Road at the Soledad Canyon Road/Valencia Boulevard Junction.


Project Location: 8th Street between Cross Street and Parkview Avenue.






Project Location: Soledad Canyon Road from Camp Plenty Road to Sierra Highway.

- **Description:** This project will underground the existing overhead utilities along Soledad Canyon Road from Camp Plenty Road to Sierra Highway, reducing the heavy concentration of overhead utilities in this area. The requested funding will provide for right-of-way costs and allow the City to provide for resident's costs of the improvements.
- **Justification:** The undergrounding will eliminate the heavy concentration of overhead electrical facilities in this heavily traveled public recreational area, improving aesthetics along the corridor. It is prudent for the City to proceed with this effort, as most of the estimated costs of \$5.5 million will be absorbed by Southern California Edison.

Project Location: Newhall Ranch Road at Golden Valley over the Santa Clara River.


