Subject: Opposition That Camp Joseph Scott Serve as a Long-Term Facility for DJJ Populations and Support for Los Padrinos Juvenile Hall

On behalf of the Santa Clarita City Council and in light of the feasibility study on the adaptive use of Camp Joseph Scott (Camp Scott), I am writing to respectfully reaffirm our concerns and opposition that Camp Scott be adopted as a long-term County facility for juvenile male serious offenders. Additionally, I would like to express our support for the consideration and designation of Los Padrinos Juvenile Hall to serve as a long-term County facility for juvenile male serious offenders, as recommended by the County Probation Oversight Commission.

In recent findings included in the feasibility study, the base construction and associated projected costs to renovate Camp Scott to a state-of-good repair was estimated to cost approximately \$37.7 million. This exorbitant cost is made worse given that the feasibility study estimates the improvements would take between 50-60 months.

A nearly \$40 million price tag coupled with a 5-year construction timeline offers little to no immediate benefit to those dispositioned to the County Probation Department's supervision and County taxpayers. The feasibility study reinforces the City's original concerns and comments made to you and the Juvenile Justice Realignment Block Grant (JJRBG) Subcommittee that Camp Scott's dilapidated conditions, location, and historical use make it infeasible to be adapted to serve juvenile male serious offenders. Additionally, the delay in the readiness of Camp Scott directly contradicts the original intent and goals of the JJRBG Subcommittee to identify facilities for the immediate relocation of those formerly under the supervision of the Division of Juvenile Justice (DJJ).

As the County Probation Oversight Commission has recommended reconsideration of Los Padrinos Juvenile Hall, it is important to emphasize that this facility remains a



highly feasible option for the long-term housing and rehabilitation of those formerly under DJJ supervision. With its centralized location to Downtown Los Angeles and its vast inventory of existing resources and capacity, Los Padrinos Juvenile Hall represents a substantial cost savings alternative to Camp Scott.

Additionally, it is critical to highlight that Los Padrinos Juvenile Hall was the highest ranked facility among juvenile facilities when it was assessed as part of the County Probation Department facility assessment, which originates from a directive included in an approved motion from the July 27, 2021, regular meeting. Los Padrinos Juvenile Hall ranked the strongest in 21 of the 31 categories included in the facilities assessment, including housing capacity, perimeter security, and land use compatibility. Camp Scott scored lower in all of the aforementioned categories in comparison to Los Padrinos Juvenile Hall.

Furthermore, with no direct proximity to homes, Los Padrinos Juvenile Hall does not impose the same incompatibility on neighboring residents that Camp Scott would. Lastly, in terms of its resiliency to potential fire and flood hazards, Los Padrinos Juvenile Hall ranked within the most responsive category, which is a stark contrast to Camp Scott, which scored the worst among juvenile facilities in this category and possesses severe complications with regard to its historical vulnerability to wildfires and floods. The significant contrast between Los Padrinos Juvenile Hall and Camp Scott is even more exacerbated given Camp Scott's poor infrastructure to accommodate emergency evacuation procedures.

It is imperative that the feasibility study and facilities assessment are taken under serious consideration, along with the comments we have made in this letter, and that Camp Scott is ultimately determined to be an unsuitable option to house juvenile male serious offenders. Furthermore, we urge you to accept the County Probation Commission's recommendations to consider and designate Los Padrinos Juvenile Hall as a permanent facility for juvenile male serious offenders.

Thank you for your consideration on this grave matter. We look forward to working with each of you in securing the most adequate resources and suitable facilities for the transition of the DJJ population. 
