The kitchen at The Centre acts *only* as a warming kitchen, where caterers can utilize the oven and microwave to warm already prepared food. The chaffing drawers allows for several food trays to be stored at a warm temperature. Guests are welcome to use the refrigerator to store drinks or cakes.

VENUE RENTAL RESTRICTIONS

GENERAL RESTRICTIONS

- All patrons must exit the building no later than 12:00 a.m.
- Patrons may not change, alter, or deface property in any facility, or to its furnishings/equipment.
- Storage of property is not permitted before or after an event.
- Restroom porter services may be required at events with 200 or more guests.
- Security services may be required at events serving alcohol or with 200 or more guests.
- Animals are not permitted in the facility except for those that are used in aiding a person with a disability.

RESTRICTIONS ON ALCOHOL

- Alcohol may only be served and consumed in an approved reserved indoor facility or designated outdoor area.
- Alcohol service is limited to five (5) hours and must cease at least 15 minutes prior to end of event.
- A bartender is required for events serving alcohol; self-service of alcohol is prohibited.
- Applicants may only sell alcohol if they have obtained a temporary sales permit from the Alcohol Beverage Control Board.

RESTRICTIONS ON DECORATIONS

- Decorations are not to be suspended, attached, or affixed to ceilings, walls, window blinds, draperies, room dividers, or doors. Renters may only use painter's tape to hang wall decorations as an exception.
- All decorations must be removed from the facility by the end of the renter's permitted rental time.
- Fog/smoke machines, bubbles, rice, confetti, birdseed, or other granular substances are prohibited.
- Helium balloons must be secured with weights and disposed properly at the conclusion of the event.

RESTRICTIONS ON ELECTRICITY

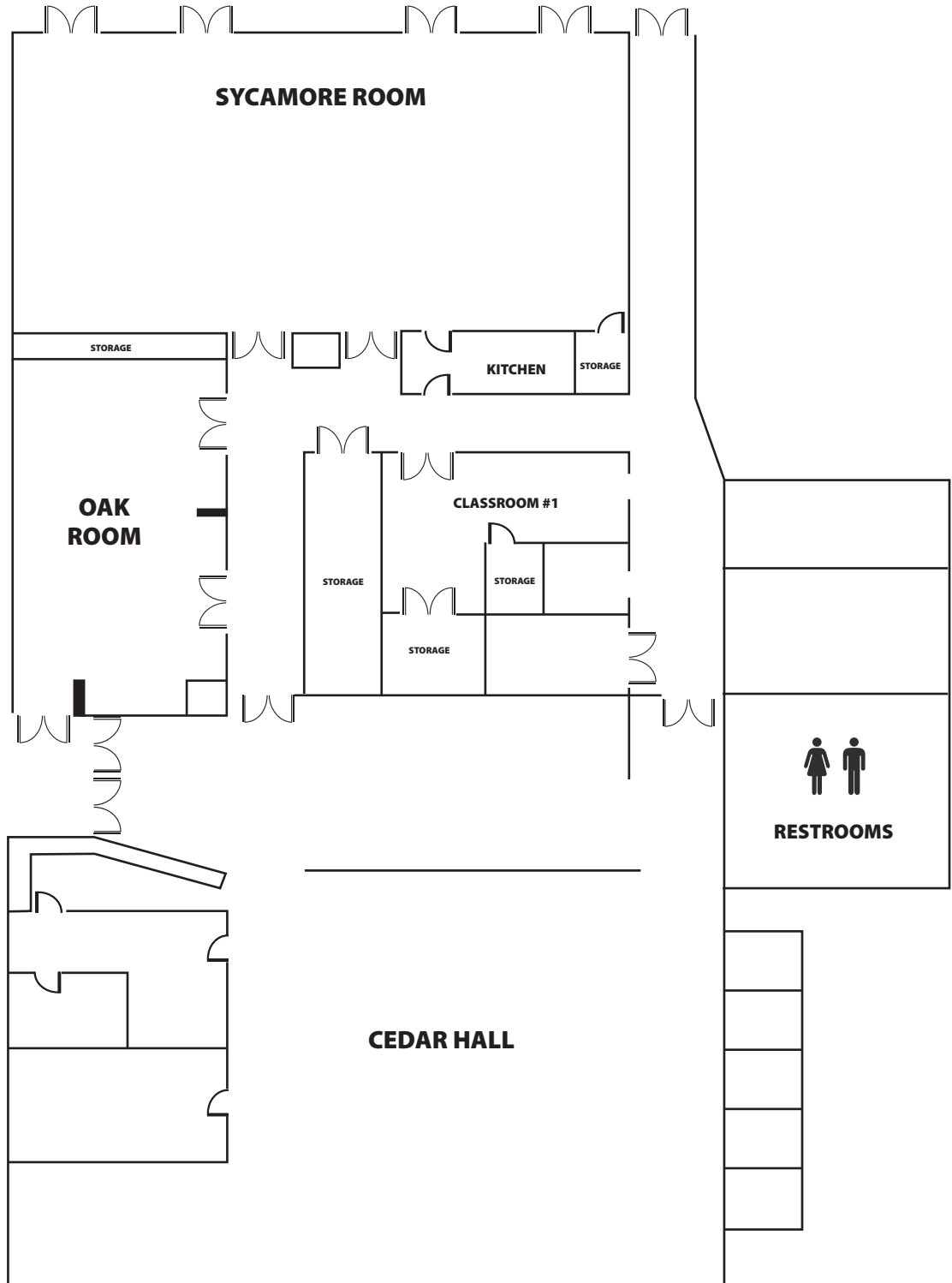
- Renters must submit a list of items that use electricity prior to the event.
- Renters must bring any necessary electrical cords. Cords must be high quality and free of defects.
- Any exposed electrical cords must be secured to avoid any tripping hazards.

RESTRICTIONS ON FOOD/CATERING/BARBECUES

- Food production may only be done in facilities with a full-service kitchen. Warming kitchens are not full-service kitchens.
- Renters are required to notify the City if they plan to bring a food truck or food cart.
- Caterers/food trucks must be compliant with fire safety regulations. The City is not responsible in the event that a fire marshal dismisses a renter's caterer/food truck.
- Caterers/food trucks/grills are required to have an approved 2A 20BC class fire extinguisher within 5-10 feet from heat source. A K class extinguisher is required for a fryer or wok.
- Grills are permitted for outdoor use only at least 10 feet away from the building; Grills must always be monitored and secured in such a way guests cannot come into contact with them.

INCIDENTALS

- If the renter extends the time of the reservation or uses additional space beyond the Agreement for Use, the City will deduct the amount owed from the renter's security deposit.
- If damage to City property occurs or excessive cleaning is required, the amount will be deducted from the renter's security deposit.
- If the security deposit is not sufficient to cover the amount owed, the renter is responsible for paying the additional money owed to the City.

Special Event Insurance Program – Alliant



Important Information for Potential Applicants

- The City of Santa Clarita offers tenant/users, and instructors the option to purchase insurance coverage directly through the City's insurance company, Alliant. It applies to permitted event reservations or classes and meets the insurance requirements included in these agreements. It is not required for a tenant/user or instructor to purchase this coverage, insurance may be secured through a private broker or agency.
- Acceptance into this program is *not guaranteed* and applications are subject to evaluation and approval by City of Santa Clarita Risk Management staff. If an application is rejected, the activity may not fit within the parameters of this program, however insurance will still be required for the agreement to proceed and may be acquired through a private broker or agency.
- Concessionaires or vendors hired by applicant to provide services at a permitted event are the responsibility of the applicant. Applicant can include these vendors as additional insured on the policy for an additional fee. Some concessionaires/vendors cannot be added to this policy based on exclusions set in place by the City's insurance company. These exclusions include but are not limited to concert/stage performers, inflatable structure (bounce house) operators, fireworks/pyrotechnic operators, mechanical devices/amusement rides, tent rental, political events.
- Some instructors cannot be added to this policy based on exclusions set in place by the City's insurance company. These exclusions include but are not limited to concert/stage performances, boxing/wrestling/contact karate, hockey, professional sporting, bounce house/trampoline, roping instruction.
- Instructor coverage:
 - Premiums are applied based on per total class attendance regardless of number of days/weeks of instruction.
 - Instructor must include in the application whether the same students will be attending all class dates for the duration of session or if different people will be attending each class for the duration of the session.
 - This program is only available to instructors of City-organized contract classes at this time.

- Tenant/User multi-day reservations:
 - Include days that will be used for set up or take down. These dates will need to be covered by the policy.
 - Attendance will be based on the total for all days of the event.
 - Permitted events lasting over five days require special approval.
 - Liquor liability coverage is available for accepted events. For multi-day events involving alcohol, premiums are applied for each day of the event.
 - If an event extends beyond midnight and ends before 2:00 a.m. the event is considered one day. If the event extends beyond 2:00 a.m. an additional day will be charged for the liquor premium (if applicable) and event premium.
 - If an event involving alcohol extends beyond midnight and ends before 2:00 a.m. (excluding take down days) a 15% surcharge will be added to the liquor premium.

- Standard Limits* are as follows:
 - \$2,000,000 General Aggregate
 - \$1,000,000 Products/Completed Operations Aggregate
 - \$1,000,000 Personal and Advertising Injury
 - \$1,000,000 Each Occurrence
 - \$ 100,000 Damage to Premises Rented to You
 - \$ 5,000 Medical Expense

**limits may vary based on event type/duration*

All aggregates apply separately to each event

Participation in this program is not mandatory. Insurance may be purchased from a private broker or insurance company.

If the contract between the additional insured and you requires that the insurance afforded by this policy be primary and noncontributory, this insurance shall be primary and noncontributory but only as to the general liability policy(ies) where that additional insured is listed as the named insured on the declaration page(s) of such policy(ies).

All other terms and conditions of this policy remain unchanged.
