Gate-King Industrial Park Final Additional Analysis SCH# 2001021121 Response to Comments

In compliance with Section 15132 of the *California Environmental Quality Act (CEQA) Guidelines*, this document serves as the Final Additional Analysis for the proposed Gate-King Industrial Park project (Master Case No. 99-264, Tentative Tract Map 50283, General Plan Amendment 99-003, Zone Change 99-002, Oak Tree Permit 99-029, Conditional Use Permit 99-013, Hillside Review 99-004, and Development Agreement 99-002).
