SUBJECT: AB 893 (FONG): OPPOSE

On behalf of the Santa Clarita City Council, I am writing to respectfully express our opposition to Assembly Bill 893, related to requiring cities and counties to approve affordable housing projects located within a one-half mile radius from a college or community college. The Santa Clarita City Council voted to oppose this measure on April 22, 2025.

> The City of Santa Clarita (City) has experienced a significant amount of growth in the last 30 years, more than doubling in population to over 230,000 residents. Currently, there are approximately 13,000 units that are in some phase of the housing development and construction process in Santa Clarita. This accounts for a 19 percent increase in housing units in the City, with approximately 75 percent of future units as multi-family units.

Marsha McLean Councilwoman

> While we appreciate your goal to expand housing, Assembly Bill 893 significantly preempts local land use and zoning review and authority. Specifically, we have concerns of the bill's streamlined ministerial provision which precludes projects from being subject to an appeals process, public hearing, local zoning, and California Environmental Quality Act (CEQA) review.

Typically, large housing development projects undergo an extensive review process including public hearings, administrative review, and an opportunity for appeal. This allows for the City's Planning Division, Planning Commission, and the public, the ability to review residential projects based on unique community circumstances, and ensures that a site has adequate access to services and resources to sustain residential use and density.

The bill's streamlined and ministerial provision jeopardizes the due diligence and responsibilities held by local governments to ensure projects are vetted to

preserve public health, safety, and welfare. This includes confirming public utility services such as power, water, and sewage meet anticipated population, dwelling unit densities, and service requirements. Additionally, local zoning is established in the City to mitigate traffic congestion and ensure that adequate and innovative infrastructure is developed to preserve public welfare and safety. It is critical for the City to maintain local land use and zoning authority and ensure that the City continues to have the ability to consider unique factors when reviewing residential development proposals.

For these reasons, the City of Santa Clarita respectfully opposes Assembly Bill 893.
