Reference: Wiley Canyon Road Area – Traffic Count Comparison

This memo presents a comparison between traffic counts collected in September 2022 to those previously collected in March 2021 as used in the Wiley Canyon Mixed Use Project traffic study. As shown in Table 1, traffic counts on Wiley Canyon Road and Calgrove Boulevard are generally the same in 2022 as they were in 2021. Traffic counts collected in September 2022 on the nearby neighborhood streets are also shown for informational purposes. The new counts do not affect the analysis or the conclusion of the traffic study.
