Party Policies & Procedures

1. The group area reservation fee must be paid in full upon booking in order to reserve date/time. The reservation fee entitles the booking party to the use of their area and includes admission fees. Unfortunately, we are not able to save any reservations without payment. Must be at least 18 to reserve a party.
2. To be fair to all participants, a maximum of **two party** areas can be booked per party day, per family. **Any reservations that exceed these maximums will be cancelled and refunded.**
3. Admission for all guests is included in your reservation fee and includes anyone entering the facility, regardless if they enter the water. Wristbands will be given to the party host upon arrival. The host will be responsible for distributing wristbands to guests. **For safety reasons, you will not be able to exceed your maximum allowed number of guests, no exceptions.** However, you may book up to two party areas to accommodate more guests.
4. Outside food and drinks will be allowed during parties. No alcohol or glass containers allowed.
5. Please note, there is no storage space (refrigerated or other) available at the Aquatic Center; however, you may bring a cooler to keep your food cold.
6. The only decorations allowed are tablecloths and place settings, as well as signs; but please keep in mind that everything must be secured due to high winds. Sorry, balloons are not allowed.
7. The booking party is the individual in charge of the event, and will need to be in attendance throughout the duration of the event. In addition, the booking party will be asked to verify that all conditions are met during the event.
8. All setup and cleanup is the responsibility of the booking party. Group area will be available 15 minutes prior to reservation time for setup and up to 15 minutes after for party festivities and cleanup.
9. The Dive Pool is not available during party rental time.
10. Changes, alterations, or defacement of property to any facility, its furnishings, or equipment will not be permitted. Any person or group causing damage to property or equipment will be required to pay for current cost of repair, including labor, or replacement to restore furnishings or equipment to its original condition. Until full payment for damage is received, the City of Santa Clarita will deny future application and/or registration for all programs.
- 11. Children, ages six and under, are required to have an adult in the water with them (within arm's length) at all times. In addition, we ask there to be one adult chaperone for every ten children in your party.**
12. Cancellations requested at least 14 days prior to the reservation date will receive a full (100%) refund. Cancellations made 7-13 days prior to the reservation date will receive a fifty percent (50%) refund. No refunds will be issued after this time.
13. If no parties are booked for any given date, the City will cancel that date two weeks prior. Reservations will close fourteen (14) days prior to the party date. All party dates are subject to availability. The Santa Clarita Aquatic Center is not available for party reservations on any holidays or special events. Please call or check online for availability, (661) 250-3740.
- 14. For the safety of all party participants, all pool rules and regulations must be obeyed at all times. Please share the attached Pool Safety Rules with guests prior to reservation date.**

**City pool facilities have maximum occupancy limits established by the Los Angeles County Health Department. All guests entering the pool facility during party rentals are considered an occupant whether they intend to swim or not.*

Pool Safety Rules

1. Anyone who enters the facility will be counted as part of the maximum capacity.
2. Please obey the direction of Lifeguards and Aquatic Center staff.
3. Swimsuits must be worn in the water at all times.
4. Children, two and under, must wear swim diapers under their suits.
5. Only Coast Guard-approved lifejackets are permitted. There are a limited number of lifejackets available to borrow for FREE.
6. For the safety of the swimmers, the use of masks, fins, snorkels, or any toys are not permitted in the pool.
7. Please walk at all times.
8. There is no diving in the shallow end of the pool.
9. Dangerous horseplay, including hanging on other swimmers backs, is prohibited.
10. Please do not sit or hang on the buoy line.
11. No glass containers permitted in the pool facility.
12. The use of drugs, alcohol, or tobacco products is strictly prohibited.
13. Pets are not allowed in the facility at any time. Only service animals are allowed.
14. Lifeguard towers are for Lifeguards only.
15. Children, ages six and under, must be accompanied in the water by an adult at all times.
16. Active in-water supervision by an adult is required for all non-swimmers.
17. Leaders of organized groups are responsible for the conduct of their group at all times. Additional rules may apply, check with Lifeguard.



Waterslide Safety

1. All riders must be at least 48 inches tall to ride the waterslide.
2. Please do not stop, slow down, or form a chain of riders on the slide.
3. Do not stand up on the slide at any time.
4. The riding position is lying on the back with feet first or sitting facing forward.
5. For safety reasons, lifejackets, shorts, eyeglasses, sunglasses, or goggles may not be worn on the slide at any time.
6. Riders are asked to wait until the Lifeguard signals them to enter the slide.
7. Only one patron on the slide is permitted at a time.
8. Please do not roughhouse or horseplay on the stairs at any time.
9. Swimsuits with plastic or metal pieces on them are not permitted on waterslide.
