

Checklist for entitlements that require **Public Noticing Type II**

(With Public Hearing)

Type II public noticing and a public hearing before the Planning Commission and/or City Council are required for Class IV, V, VI and VII entitlement applications pursuant to <u>Section 17.06.110</u> of the Unified Development Code (UDC). These entitlements include: Conditional Use Permit (CUP), Hillside Development Review (HDR), Tentative Parcel/Tract Map (TPM/TTM), Variance (VAR), etc.

Public Noticing (Type II) Submittal Requirements

Applications shall be reviewed for compliance with these submittal requirements. *Applications submitted without the required information may not be accepted for processing or may be deemed incomplete and processing suspended.*

A.

____ Two (2) copies of a Land Use/Property Ownership Radius Map (1,000' radius) indicating:

- □ A 1" to 100' scale
- □ Subject property and dimensions
- □ All surrounding properties and current lot lines within the 1,000' radius (measured from exterior boundaries of subject property)
- □ All streets, highways, alleys, right-of-ways, bike paths, paseos, trails, etc.
- □ All tract, lot, and house numbers
- □ Existing uses on all lots, parcels, properties within radius (house, apartments, store, etc.)
- □ Ownership of all properties within a 1,000' radius (number the lots to correspond to the property owners list described below)



B. ____ Notarized Certified Property Owner's List Affidavit signed by the preparer of the notices (attached)

C. ____ List of Property Owners/Tenants with the following information:

- Names and mailing addresses of current owners as they appear on the latest available assessment roll of the Los Angeles County Assessor of each property or portion of property within a 1,000' radius of the subject property
- Assign a number to each name on the list and indicate the corresponding numbers on the lots or parcels on the Property Ownership Map
- □ If a multi-unit housing complex (i.e. apartments, condos, mobilehome park) exists within the 1,000' radius, label each unit as "Occupant" and include the address and unit number
- □ If the project is located within an commercial/industrial center, provide the name and address of each tenant within the center

D. ____ Mailing Labels of Property Owners:

□ Two (2) complete sets of mailing labels for all property owners within a 1,000' radius from the exterior boundaries of the subject property. Labels shall include:

Name(s) and address(es) of:

- □ Property owners of the proposed project site
- □ Applicant, if different from the owner
- Applicant's representative, engineer, architect, and/or surveyor
- □ Occupants of any multi-unit housing complex (i.e. apartments, condos, mobilehome park) located within the 1,000' radius of the property. Such labels shall be addressed to "Occupant"
- **D** Each business and/or tenant, if the project is located within a commercial/industrial center
